Update on Member Survey

In February and May 2017, NRIG sent out an online survey by email to learn more about our members and

hear what is important to you! The NRIG executive is using this information in our strategic planning for the next two years (2017-2019). In total, we received 90 responses and we thank all of you who took the time to complete the survey and provide such valuable feedback to us. We are using this information to ensure we address our members' priority needs.

• Policy and Political Action •

It was an honour to attend the 17th Annual Queen's Park Day on February 23th and 24th, 2017. My first time at the event was exciting. It was a great opportunity to represent nurses across the Province and to bring forth NRIG's Policy and Political Action agenda. There were many progressive changes during the two-day event. During our first day, Barbara Chyzy and I attended RNAO's assembly meeting and had the opportunity to network with fellow nurses, nurse leaders, community members and activists. Over the course of our days at Queen's Park, we met with key figures in Ontario's parliament as well as learned about the history of the provincial legislature and the legislative process. My colleagues and I met with MPPs including Premier Kathleen Wynne, Minister Hoskins, Patrick Brown and Health Critic Jeff Yurek to discuss key issues concerning the nursing profession and practice in Ontario. Shortly after our meetings, we attended the Legislative Assembly at the Ontario Legislative Building at Queen's Park where we were introduced by our local MPPs, which was followed by stages of debate and decision-making.

RNAO and other nursing organizations have been working diligently to advocate for advancement in nursing practice including RNs prescribing medications independently and increasing NP scope of practice to include to prescribing controlled substances. We are thrilled resolutions were made on Day Two. The goals came to fruition when health minister Eric Hoskins announced amendments to the Nursing Act for this spring to give RNs the authority to independently prescribe



medications and communicate diagnoses and NPs to prescribe controlled substances. I was delighted to witness such great work by outstanding leaders in our community and the leadership and political stance that was taken by nurses to advocate for this change in nursing practice across the Province.

At the last day of the event, we attended the Annual Interest Group meeting where we discussed ways to support the needs of our current members, recruitment strategies, and the mission and vision of RNAO. Overall, the days at Queen's Park were indubitably successful. Although specific goals set forth by NRIG to raise awareness about the importance of nursing research and alternative funding sources for novice researchers were not directly addressed at this event, we are optimistic that there will be other opportunities to put forth our agenda to support our current and future members of NRIG.

• In the Spotlight •



This year, I had the pleasure of attending the Annual Scientific Meeting for the Canadian Pain Society in rainy Halifax, Nova Scotia. I was in attendance to present two poster presentations based on my master's thesis in nursing that was partially funded by a scholarship I was awarded in 2016 by NRIG. Thanks to this scholarship, I

was able to apply the funds to transcription services for my qualitative study to help accelerate the analysis of one of the studies.

The Canadian Pain Society planned a very exciting and innovative program for this year. The program included experts in the field discussing highly debated topics dominating the public news such as the opioid crisis, marijuana use, and kangaroo care for neonatal procedural pain management. One of the most innovative features was the accreditation of the conference to be patients included. Not only did the conference award multiple patient scholarships for patients to attend the full conference program, they were included in panel discussions and invited to speak at the trainee workshop. It was incredibly moving and inspiring to hear from patients throughout the conference as their feedback and questions are invaluable to continuing any body of research. I felt from a nursing perspective that it brought back the attitude of maintaining a holistic view in research. Patients are the reason most of us became a nurse, and we should never lose sight of that.

The presentation of both my posters at this conference was a great learning experience for myself. I was able to connect and network with many of Canada's top pain scientists in a variety of fields. Pain research extends from nursing to psychology, medicine and basic science. I was also able to discuss the unique contextual needs of nurses who work in rural Northern Ontario in regards to their experience in dealing with pediatric pain management. Presenting my findings was important to me, as there is a paucity of pediatric pain literature dedicated to the rural



context in Canada, as most of it has focused in tertiary care settings.

I would like to thank NRIG again for the award of the Nursing Research Interest Group. I am grateful that I was able to attend and disseminate my research to a topic close to my heart. The abstracts of my accepted poster presentations of both my research studies are published in the very first journal for the Canadian Pain Society, *Canadian Journal of Pain*.
