•Research Webinars •



On December 18, 2019, NRIG was pleased to offer the webinar- *The DIVERT CARE Trial*, presented by Dr. Connie Schumacher and NRIG board members. Dr. Schumacher is a RN with 25 years of direct clinical experience in emergency, cardiology and community health sectors as well as clinical instructor experience. Dr. Schumacher's research interests include self-management practices in chronic disease and care at transitions, focusing on heart failure, COPD and geriatric populations.



An expert on the interRAI DIVERT Scale, a pre-emptive tool that identifies home care patients at risk for a future emergency department visit, Connie has been actively designing clinical applications for the DIVERT Scale outputs to facilitate uptake and promote practice. Current research includes the DIVERT-CARE Trial, the DIVERT-CARE Experiences multiple case study, trends in homecare characteristics and service use, the association of afterhours care and emergency department use in home care populations, and collaboration on a study of immigrants in long-term care change.

The webinar covered topics including knowledge translation and practice change process, developing the DIVERT Scale and related research, the DIVERT CARE Catalyst and Pragmatic Trial, People, Processes & Policy, Practice Change and the DIVERT Clinical Applications Guide for future implementation. On January 14, 2020, NRIG was pleased to offer our second webinar- An Introduction to Statistical Analysis by Meaghan Davey. Meaghan Davey is a nurse-epidemiologist and contributes to study

design, conduct and reporting at the Schlegel Centre for Advancing Seniors Care at Conestoga College.

Meaghan specializes in developing sophisticated research which is highly relevant to industry and clinical practice. Her research interests include long-term care, gerontology, and quantitative research.

The webinar was an excellent resource for undergraduate or graduate students interested in familiarizing themselves on statistical analysis or for novice & experienced researchers requiring a refresher. Advancing Reminiscence Therapy through Virtual Reality Application to Promote Social Connectedness of Persons with Dementia:



NRIG's previous executive board member, Dr. Winnie Sun, recently received the Ontario Shores Centre for Mental Health Sciences-Ontario Tech University Joint Funding in Dementia Care 2019. This project aims at developing an innovative, non-traditional framework prototype to improve the implementation of reminiscence therapy for persons with dementia through customized, immersive and interactive virtual reality (VR) experiences.

Reminiscence therapy is a multi-sensory treatment that uses a combination of sight, touch, taste, smell and sound to help persons with dementia (PWD) remember events, people and places from their past lives. Reminiscing about memories can positively impact PWD by empowering an increased self-confidence in their strengths and capabilities. It will also provide PWD with the opportunity to explore with their caregivers about what holds meaning for them.

At the present, mostly conventional, analog media is being used for reminiscence intervention. Enriching the traditional form of reminiscence therapy with VR can empower the caregivers to customize individualized virtual reminiscence experiences, which is expected to help PWD with maintaining and preserving their personal identity during disease progression and challenging circumstances associated with behaviours and psychological symptoms of dementia (BPSD).

We are proud to announce the 2020 NRIG Awards, Scholarship and Grants:

Conference Grant: 2 x \$500

The NRIG Conference Grant will be awarded to a NRIG member who is attending or presenting at a conference (preference will be given to NRIG members presenting at a conference and those who have no alternative conference funding). Applicants must be a member of NRIG for a minimum of 2 years.

Undergraduate Award: 2 x \$250

The NRIG Undergraduate Award will be awarded to an NRIG member who is currently enrolled in an Undergraduate Nursing program. Applicants must be a member of NRIG.

New NRIG Member Award: 2 x \$500

The New NRIG Member Award will be awarded to a new NRIG member who is currently enrolled in a Master's or PhD program (preferably in nursing) or who is a novice nurse researcher (defined as a nurse who has completed their Master's or PhD degree within the past 5 years). Applicants must be members of NRIG for less than 2 years and must agree to maintain NRIG membership for a minimum of one year.

NRIG Scholarships: 2 x \$1500

NRIG Research Grant (Novice Researcher): 1 x \$3000

The NRIG Research Grant will be awarded to a NRIG member who is currently a New Investigator (defined as a postdoctoral fellow or a researcher who has obtained their MN or PhD within the last 5 years). Preference will be given to NRIG members who have not received a previous scholarship or grant. Applicants must be members of NRIG for a minimum of 2 years.




Mitacs Accelerate


Banting Research Foundation
